**MEMORANDUM OF UNDERSTANDING**  
**Between The**  
**ROUND ISLAND LIGHTHOUSE PRESERVATION SOCIETY**  
**And The**  
**USDA, FOREST SERVICE**  
**HIAWATHA NATIONAL FOREST**

This MEMORANDUM OF UNDERSTANDING (MOU) is hereby made and entered into by and between the Round Island Lighthouse Preservation Society, hereinafter referred to as "Cooperator," and the USDA, Forest Service, Hiawatha National Forest, hereinafter referred to as the "U.S. Forest Service."

Title: Maintain Round Island Lighthouse

**PURPOSE:** The purpose of this MOU is to document the cooperation between the parties to provide a framework to manage and maintain the Round Island Lighthouse hereafter referred to as the Lighthouse, associated buildings and grounds of the Lightstation hereafter referred to as the grounds. This cooperation serves the mutual interests of the parties and the public under provisions of the Multiple-Use Sustained Yield Act of 1960 (P.L. 86-517), Volunteers in the National Forest Act of 1972 (P.L. 92-300), National Historic Preservation Act of October 15, 1966 (P.L. 89-665), the Organic Administration Act of 1897, and other laws. in accordance with the following provisions.

**I. STATEMENT OF MUTUAL BENEFIT AND INTERESTS:**

The Forest Service and the Round Island Lighthouse Preservation Society, a Michigan non-profit corporation, have established this agreement to help one another accomplish mutually beneficial objectives related to the preservation, restoration, maintenance and interpretation of Lighthouse and grounds.

The Forest Service owns and administers the Lighthouse and grounds which is listed in the National Register of Historic Places located on the northwestern-most tip of Round Island in the straits of Mackinac, Michigan. It is the policy of Congress that the National Forests are administered for wilderness, outdoor recreation, range, timber, watershed and wildlife and fish purposes. The Forest Service is responsible for the Lighthouse, the historic artifacts and objects contained therein and its associated buildings and grounds.

The Round Island Lighthouse Preservation Society is a Michigan non-profit corporation designated as a public purpose charity by the US Department of Treasury, Internal Revenue Service, pursuant to Section 501 C (3) of the Internal Revenue Code solely to assist the Forest Service to facilitate the preservation of the Round Island



Lighthouse and grounds, and to provide public access in accord with an approved Lighthouse Facilities Management Plan. To this end, the Round Island Lighthouse Preservation Society intends to solicit and secure, with the consent of the Forest Service, grants and donations from both public and private sources to be used on the Lighthouse and grounds.

Additionally, the Round Island Lighthouse Preservation Society intends to assist the Forest Service in the provision of educational programs, interpretation of the history of the Lighthouse, collection of artifacts and memorabilia concerning the history of the Lighthouse and, when possible, creation of public accessible interpretative displays.

In consideration of the above premises, the parties agree as follows:

## **II. COOPERATOR SHALL:**

- A. Contribute to the management, maintenance and use of the Lighthouse and grounds as agreed to in the Facilities Management Plan.

## **III. THE U.S. FOREST SERVICE SHALL:**

- A. Prepare a Facilities Management Plan for the Lighthouse and grounds, including determining the level of management, restoration, and use.

## **IV. IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:**

### **A. DISSOLUTION OF THE ROUND ISLAND LIGHTHOUSE PRESERVATION SOCIETY AND TRANSFER OF ASSETS.**

Acknowledgement is made that upon dissolution of the Round Island Lighthouse Preservation Society nonprofit corporation, pursuant to the terms of its Bylaws; remaining assets shall be transferred to the Forest Services for use in furtherance of the maintenance and preservation of the Lighthouse and grounds.

- C. **NON-LIABILITY.** The U.S. Forest Service does not assume liability for any third party claims for damages arising out of this instrument.
- D. **NOTICES.** Any communications affecting the operations covered by this agreement given by the U.S. Forest Service or Cooperator is sufficient only if in writing and delivered in person, mailed, or transmitted electronically by e-mail or fax, as follows:

To the U.S. Forest Service Program Manager, at the address specified in the MOU.

To Cooperator, at Cooperator's address shown in the MOU or such other address designated within the MOU.

Notices are effective when delivered in accordance with this provision, or on the effective date of the notice, whichever is later.

- E. **PARTICIPATION IN SIMILAR ACTIVITIES.** This MOU in no way restricts the U.S. Forest Service or Cooperator from participating in similar activities with other public or private agencies, organizations, and individuals.
- F. **ENDORSEMENT.** Any of Cooperator's contributions made under this MOU do not by direct reference or implication convey U.S. Forest Service endorsement of Cooperator's products or activities.



- G. NONBINDING AGREEMENT. This MOU creates no right, benefit, or trust responsibility, substantive or procedural, enforceable at law or equity. The parties shall manage their respective resources and activities in a separate, coordinated and mutually beneficial manner to meet the purpose(s) of this MOU. Nothing in this MOU authorizes any of the parties to obligate or transfer anything of value.

Specific, prospective projects or activities that involve the transfer of funds, services, property, and/or anything of value to a party requires the execution of separate instruments and are contingent upon numerous factors, including, as applicable, but not limited to: agency availability of appropriated funds and other resources; cooperator availability of funds and other resources; agency and cooperator administrative and legal requirements (including agency authorization by statute); etc. This MOU neither provides, nor meets these criteria. If the parties elect to enter into an obligation instrument that involves the transfer of funds, services, property, and/or anything of value to a party, then the applicable criteria must be met. Additionally, under a prospective instrument, each party operates under its own laws, regulations, and/or policies, and any Forest Service obligation is subject to the availability of appropriated funds and other resources. The negotiation, execution, and administration of these prospective instruments must comply with all applicable law

Nothing in this MOU is intended to alter, limit, or expand the agencies' statutory and regulatory authority.

- H. USE OF U.S. FOREST SERVICE INSIGNIA. In order for Cooperator to use the U.S. Forest Service insignia on any published media, such as a Web page, printed publication, or audiovisual production, permission must be granted from the U.S. Forest Service's Office of Communications. A written request must be submitted and approval granted in writing by the Office of Communications (Washington Office) prior to use of the insignia.
- I. MEMBERS OF U.S. CONGRESS. Pursuant to 41 U.S.C. 22, no U.S. member of, or U.S. delegate to, Congress shall be admitted to any share or part of this instrument, or benefits that may arise therefrom, either directly or indirectly.
- J. FREEDOM OF INFORMATION ACT (FOIA). Public access to MOU or agreement records must not be limited, except when such records must be kept confidential and would have been exempted from disclosure pursuant to Freedom of Information regulations (5 U.S.C. 552).
- K. PUBLIC NOTICES. It is the U.S. Forest Service's policy to inform the public as fully as possible of its programs and activities. Cooperator is/are encouraged to give public notice of the receipt of this instrument and, from time to time, to announce progress and accomplishments. Press releases or other public notices should include a statement substantially as follows:



"Historic Preservation Programs of the U.S. Forest Service, Department of Agriculture, Hiawatha National Forest."

The Cooperator may call on the U.S. Forest Service's Office of Communication for advice regarding public notices. The Cooperator is/are requested to provide copies of notices or announcements to the U.S. Forest Service Program Manager and to The U.S. Forest Service's Office of Communications as far in advance of release as possible.

- L. U.S. FOREST SERVICE ACKNOWLEDGED IN PUBLICATIONS, AUDIOVISUALS AND ELECTRONIC MEDIA. Cooperator shall acknowledge U.S. Forest Service support in any publications, audiovisuals, and electronic media developed as a result of this MOU.
- M. NONDISCRIMINATION STATEMENT – PRINTED, ELECTRONIC, OR AUDIOVISUAL MATERIAL. The Cooperator shall include the following statement, in full, in any printed, audiovisual material, or electronic media for public distribution developed or printed with any Federal funding.

*"In accordance with Federal law and U.S. Department of Agriculture policy, this institution is prohibited from discriminating on the basis of race, color, national origin, sex, age, or disability. (Not all prohibited bases apply to all programs.)"*

- N. TERMINATION. Any of the parties, in writing, may terminate this MOU in whole, or in part, at any time before the date of expiration.
- O. DEBARMENT AND SUSPENSION. Cooperator shall immediately inform the U.S. Forest Service if they or any of their principals are presently excluded, debarred, or suspended from entering into covered transactions with the federal government according to the terms of 2 CFR Part 180. Additionally, should Cooperator or any of their principals receive a transmittal letter or other official Federal notice of debarment or suspension, then they shall notify the U.S. Forest



Service without undue delay. This applies whether the exclusion, debarment, or suspension is voluntary or involuntary.

- P. MODIFICATIONS. Modifications within the scope of this MOU must be made by mutual consent of the parties, by the issuance of a written modification signed and dated by all properly authorized, signatory officials, prior to any changes being performed. Requests for modification should be made, in writing, at least 30 days prior to implementation of the requested change.
- Q. COMMENCEMENT/EXPIRATION DATE. This MOU is executed as of the date of the last signature and is effective through 5 years at which time it will expire, unless extended by an executed modification, signed and dated by all properly authorized, signatory officials.
- R. AUTHORIZED REPRESENTATIVES. By signature below, each party certifies that the individuals listed in this document as representatives of the individual parties are authorized to act in their respective areas for matters related to this MOU.
